Northern Territory Rates Act

I, Bess Nungarrayi Price, Minister for Local Government and Community Services, for the year commencing 1 July 2015, in respect of each allotment in the prescribed area:

- (a) under section 13(1) of the *Northern Territory Rates Act*, declare a rate of 0.3252 cents in the dollar, which is a valuation-based charge, to be the rate payable in respect of an allotment; and

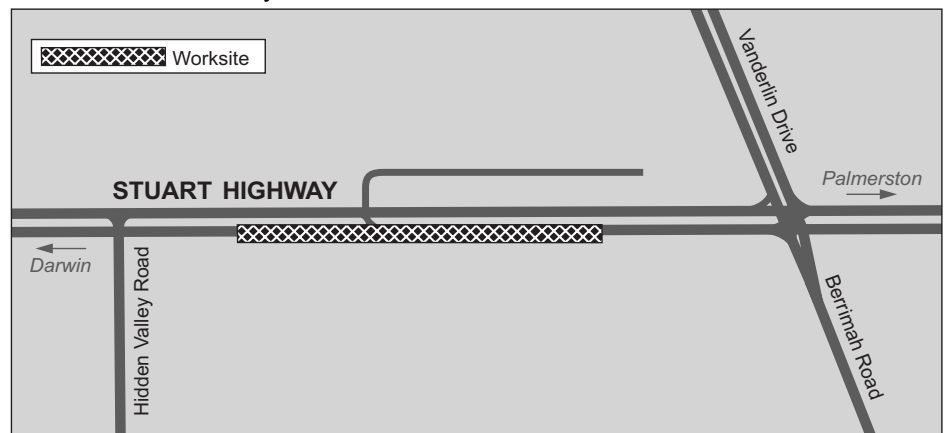

STUART HIGHWAY INTERSECTION INBOUND FROM BERRIMAH ROAD INTERSECTION TO THE HARVEY NORMAN DRIVEWAY

Asphalt resurfacing works will be carried on **Wednesday 14 and Thursday 15, October 2015**, on the inbound lanes on the Stuart Highway from Berrimah Road intersection to the Harvey Norman driveway

To minimise impact on traffic and allow for works, temporary lane closures will be in place.
